Dissertation Competition

The Urban Geography Specialty Group of the Association of American Geographers announces its Fourth Annual Dissertation Award for Recent doctoral dissertations in urban geography. Dissertations addressing any aspect of urban geography and submitted for a degree awarded during the 1985 calender year are eligible. Winning dissertations in the competition's first three years have addressed questions pertaining to the spatial structure of local labor markets, the territorial expansion of urban settlement, a comparative analysis of historic districts, family and class in a new industrial city, and relationships between home ownership and political orientation and activism.

The winner of the UGSG Dissertation Award will be announced at the Annual Meeting of the Association of American Geographers in Minneapolis, MN (4-7 May 1986) and will receive a selection of books courtesy of John Wiley and Sons. The dissertation review committee is composed of H. Briavel Holcomb (Rutgers), Neil Smith (Columbia), and its chair, Donald C. Dahmann (U.S. Bureau of the Census).

Individuals wishing to enter the competition should send <u>one</u> copy of their dissertation and a dissertation abstract to: Dr. Donald C. Dahmann, Population Division, U.S. Bureau of the Census, Washington, D.C. 20233. Entries must be received by 1 January 1986.
