Graduate Student Paper Competition: Deadline, January 31st, 2008

The UGSG Graduate Student Paper Competition Committee solicits submissions of single-authored papers presented by a student at any professional meeting in the 12 months preceding (and including) the Boston AAG conference. Preference will be given to fully developed academic papers. The winner of the award will receive \$100 and an invitation to submit the paper to Urban Geography. Dissertation Competition: Deadline January 31st, 2008

The UGSG Dissertation Competition Committee solicits submissions of single-authored papers based on the applicant's dissertation (not full dissertations). The dissertation must have been completed during the 2007 calendar year. The paper need not be presented at the 2008 AAG meeting in order to be eligible. Preference will be given to fully developed academic papers. Papers submitted to the UGSG Graduate Student Paper Competition will not be considered for the Dissertation Award. Papers submitted for awards with other AAG-affiliated organizations are not eligible. The winner of the award will receive \$250 and an invitation to submit the paper to Urban Geography. Glenda Laws Undergraduate Paper Award: Deadline January 31st, 2008

Please encourage your students to submit papers to the Glenda Laws Undergraduate Paper competition. This award goes to the best paper on an urban geographic topic written by an undergraduate student, regardless of membership in the AAG or participation in the AAG meetings. The winner of the award will receive \$50. Papers submitted for awards to other AAG-affiliated organizations are not eligible. Student Travel Support: Deadline January 31st, 2008

The UGSG has a small amount of money available to support students presenting on urban topics at the Boston AAG meeting. A limited number of travel awards, each worth \$100, will be awarded. They are intended to support presentations on topics related to the urban focus of the specialty group. To apply, send a short letter stating your degree program, your institutional affiliation, and your goals and purposes in attending the conference. Also include copies of your abstract and conference registration. Urban Geography Graduate Student Fellowships: Deadline January 31st, 2008

Each year, the Urban Geography Specialty Group will award one Master's fellowship (approximately \$300) and one or more doctoral fellowships (each approximately \$500), to support urban-oriented Master's and doctoral research. Fellowships are intended to provide targeted support for original Master's research and for those at a relatively early stage of doctoral dissertation research -- while also ensuring that award recipients have well-developed research proposals that have a high likelihood of completion. Fellowship support may be used for any reasonable expenses associated with a research proposal. Eligibility is limited to current student members of the Urban Geography Specialty Group who will have completed all Master's or Ph.D. requirements except the thesis or dissertation by the end of the semester or term in which any award is approved. Dissertation supervisors must certify eligibility by signing the application form or emailing emccann@sfu.ca. Submit applications by email to Eugene McCann, emccann@sfu.ca, or fax 778.782.5841, by January 31, 2008. Applications received after this date cannot be considered. Award decisions are made by the Board of the Urban Geography Specialty Group on the basis of the quality and feasibility of the research proposal. RESEARCH NOTE

Research on the Geographic Aspects of Sustainable Transport Best Practices

I discussed this topic in the Fleming Lecture that I gave at the 2007 AAG conference in San Francisco. The background paper that I prepared for the Lecture is posted on Transportation Geography Specialty Group website, and can be viewed at:

More recently, I again addressed this topic as the international speaker at the 2007 TravelWise Association (NTWA) conference in Belfast, Northern Ireland, November 7-9.

The background paper for my NTWA plenary address was titled "Sustainable transport: Is there anybody here who <u>can</u> win this game?", and the PowerPoint slide presentation was titled, "Sustainable transport by design or by default? It appears to be very clear that while we are a long way from confirming and ranking the full list of sustainable transport best practices, urban regions in Europe are far ahead of their North American counterparts when it comes to identifying, adopting, and implementing the practices that have been achieved.

However, it also appears to be very clear that in both Europe and North America, we are in the very early stages of investigating whether, why and how factors of geography affect the processes of identifying, adopting, and implementing sustainable transport best practices.

The purpose of this note, therefore, is to draw attention to an applied research domain in the field of urban transportation that provides students at all levels, as well as faculty members, an outstanding opportunity to engage in an increasingly important body of research that is in serious need of examination from a geographic perspective.

CONFERENCE ANNOUNCEMENTS

PN2008 WINNIPEG PLANNERS NETWORK CONFERENCE JULY 17-20, 2008 PLANNING IN CHALLENGING CLIMATES

PLANNERS NETWORK is an association of professionals, activists, academics, and students involved in physical, social, economic, and environmental planning in urban and rural areas, who promote fundamental change in our political and economic systems. Winnipeg and Manitoba have long histories with struggles for social justice. The city was the site of Canada's best known general strike in 1919. It played significant roles in the development of the co-operative movement in the mid-twentieth century. This led to the formation of the Cooperative Commonwealth Federation (CCF) a political party that supported farmers and workers, and called for public health insurance, public housing, and public ownership of major industries. In the early 1960s, with the Canadian Labour Congress, the CCF became the New Democratic Party – and Manitoba is currently the only province with an NDP government. There is strong history of community economic development in the city, and it is known for its high rate of volunteerism and its vibrant arts culture. The region is also known for its long winters. Unfortunately this is not the only challenging climate faced by progressive planners and advocates for social and environmental justice. The pervasive neo-liberal climate has undermined social programs; sprawl has created a climate intolerant to active transportation, and competes with the downtown core for amenities; and the growing aboriginal population struggles to overcome a history of oppression. **CALL FOR PARTICIPATION**: PN2008 will bring together an array of planning practitioners, community and economic development professionals, organizers, policy analysts, designers, students and faculty. They will discuss strategies addressing social and environmental justice in challenging climates including social, political and economic climates. Topics of interest to the conference include, but are not limited to: models for community economic development • inner city community development • art and the city • planning and aboriginal communities • neighbourhood revitalization • downtown redevelopment • housing and homelessness • promoting active transportation • urban ecology • green buildings and sustainable communities • social impacts of sprawl • heritage planning • progressive planning and the media • age-friendly communities. A range of session types are encouraged, from conventional panels to participatory workshops and "how-to" sessions. 5th international conference of the interdisciplinary research network "private urban governance/gated communities"

March 30 to April 4 2009 University of Chile, Santiago de Chile

Call for panels:

Cities around the globe are witnessing the development of new institutional arrangements by which urban spaces are organised – especially on a subcommunal scale. These new institutions involve public and private organisations, different forms of community organisations as well as organisations which cut across the public/private dichotomy. The governance of existing neighbourhoods is becoming re-engineered by institutions such as horizontal homeowner associations and business improvement districts. Newly urbanised areas are organised as private and often gated residential communities; as shopping, commercial and industrial neighbourhoods governed under multi-tenant property ownership and private government of communal space and services. The 5th conference of the research network on "private urban governance" will offer an international forum for the interdisciplinary discussion of the causes and consequences of these new forms of urban governance.

The research network was established in 1999 and is an open network of currently more than 100 researchers from urban geography, planning, architecture, regional economy, political science, sociology, anthropology and other disciplines. The preparation of the conference follows a two-tiered scheme. We invite everybody interested to organise a panel (with three to six participants) on any topic related to private urban governance to send us the title for the proposed panel and an abstract outlining the idea of the panel (ca. 200 words).

Panel proposals should be <u>submitted before the end of December 2007</u>. Please do indicate if you already have in mind some papers to be presented in this panel (title, presenter, general ideal of the paper). Panels might for example focus on specific forms of private urban governance (e.g. business improvement districts, gated communities, tax exempt improvement areas); on specific theories and approaches which might help to understand and/or evaluate the development of private urban governance (e.g. new institutional economics, theories of social segregation, politic-economic approaches, discourse theory etc); or on the development of private urban governance in specific countries or regions. Based on these proposals the scientific committee will establish a structure of panels and publish the call for papers in spring 2008.
